### How to calculate your annual fee

Your annual fee is calculated on the basis of the volume of BG/EG activity and the **inspection's complexity**.

What category is your company in?		Fee if turnover > 130.000€
<b>Processor</b>	A company that processes or transforms products.	Calculation of BG/EG turnover* + (base + number of sites + number of finished products + number of ingredients)**
<b>Packager</b>	A company that buys products, changes the packaging and then sells the product.	Calculation of BG/EG turnover* + (base + number of sites + number of finished products + number of ingredients)**
<b>Bulk product distributor</b>	A company that receives bulk or packaged but unsealed products and then sells them in the same condition.	Calculation of BG/EG turnover* + (base + number of sites + number of finished products + number of ingredients)**
For the following categories the fee is reduced by applying a coefficient on the BG/EG turnover <u>before</u> the calculation on a percentage basis:		
<b>Labeller</b>	A company that uses a label with its name on products that are already packaged and on which the manufacturer's name is not shown.	(BG/EG turnover x coefficient 0,50)* + (organic category: base + number of sites + number of finished labelling products)**
<b>Distributor/wholesaler trader</b>	A company that buys and resells products without changing the packaging, labelling or content. A company that resells to other companies but not to the end consumer.	(BG/EG turnover x coefficient 0,30)* + (organic category: base + number of additional sites)**

### Some definitions :

- **BG/EG turnover** : annual turnover from the sale of products advertised as BG/EG, and which fall under the provisions of the Biogarantie®/ Ecogarantie® specifications. These products are identified in this document as "finished BG/EG products".
- **Finished product** : for the purpose of calculating the fee, we consider 2 products to be different when they are characterised by a different manufacturing process and/or when the product ingredients are different.
- **Mixed company** : a company that processes both BG/EG and non-BG/EG products on the same production site.

### Payment terms :

- The annual fee is invoiced to you in instalments throughout the year. The total amount will be calculated when the final turnover (BG/EG turnover) is known at the beginning of the following year.
- For new applications, a deposit of 450€ is required on the opening of the file and is not refundable.
- Travel and analysis costs are included in this fee.
- The amounts calculated in this fee do not include services provided outside Belgium and the Grand Duchy of Luxembourg, which are invoiced on the basis of a quote (0,95€/km).
- Additional sites are added to the annual fee.
- Additional checks are necessary when the task is made difficult:
  - Non-accessible premises
  - Accounts not available, poorly kept or incomplete
  - Incomplete information about processing
 These additional checks are invoiced.
- In case of serious infringements, non-compliance and when the result of an analysis is positive and confirms an abnormal situation, a reinforced control will be invoiced.
- The deposit invoiced at the time of opening the file is not refundable.
- The new file rate with a new VAT number is applied for 2 years to companies with a BG/EG turnover below € 130.000.

- \* **How to calculate the volume of activity**

BG/EG turnover under € 1.250.000	0,18% of the gross turnover
On the tranche of the BG/EG turnover from € 1.250.000 to € 6.250.000	+ 0,10% of the gross turnover
On the tranche of the BG/EG turnover from € 6.250.000 to € 15.000.000	+ 0,05% of the gross turnover
On the tranche of the BG/EG turnover from € 15.000.000 to € 25.000.000	+ 0,03% of the gross turnover
On the tranche of the BG/EG turnover over € 25.000.000	+ 0,01% of the gross turnover
